## Dear Mr. Walworth:

We reviewed reference (a), received with your letter dated September 12. 2011, for compliance with the requirements of Subchapters T and S, and reference (b). Accordingly, reference (a) is "Examined." Supporting calculations such as these are not normally approved; however, the information presented is used in verifying the vessel's compliance with applicable stability requirements. As with all calculations, the responsibility for the accuracy rests with the submitter. The following comments apply:

- 1. We note that reference (a) was submitted in order to demonstrate compliance with the requirements of reference (b). You have chosen to reduce the vessel's maximum personnel load from 32 to 27 in order to compensate for the increased assumed passenger weight via the weight ratio method.
- 2. Your loading conditions assume an average weight of 185 pounds per person. Based on our review of your calculations, we concur that the subject vessel has adequate stability in all indicated conditions of loading and operation for service with up to 25 passengers and 2 crew members on an Exposed Waters route.

As we do not have sufficient information in our records to issue a revised stability letter for the vessel, we are issuing a stability letter addendum reflecting the abovementioned passenger reduction. The vessel's current stability letter will, in conjunction with the addendum, remain valid and in effect.
